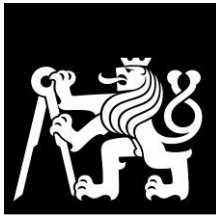

Position title:	Associate professor or Assistant professor teaching the course Urban and Regional Economics and Urban Sociology (URES) in the Master's program Planning and Development (P+D) potentially other similarly focused programs at the Faculty of Architecture, CTU (Architecture and Urbanism, Lifelong Learning – Development, etc.).
Specialization:	academic staff member for the field of Urban and Regional Economics or Urban sociology
Number of positions:	1 – Associate professor or Assistant professor
Type of position:	academic staff member – Associate professor or Assistant professor
Salary scale:	60 – 65.000 Kč monthly on a full-time basis with the possibility of performance-based personal evaluation
Workload:	0,2 (8 hours per week – part-time basis) until 08/2026, 0,5 (20 hours per week – part-time basis) from 09/2026

Job description:

- In the period until 08/2026:
 - developing a more detailed syllabus for the course URES according to the Planning and Development syllabus,
 - defining the study plan, learning objectives, and study materials
 - assembling and coordinating a team of potential additional course teachers,
 - coordinating the course content with the program quarantor, the academic council, and teachers of other courses within the P+D program.
- In the period from 09/2026:
 - performing the role of course quarantor for URES, according to the internal regulations of CTU,¹

- formation of a subject team with experts from complementary and related fields (e.g. management, urban studies, public administration etc.)
- teaching the course URES in the Master's program P+D and potentially other similarly focused programs at the Faculty of Architecture, CTU (Architecture and Urbanism, Lifelong Learning – Development, etc.),
- participating in the operations of the department and faculty.

Requirements:

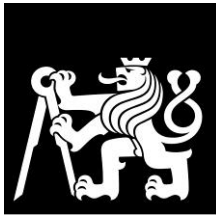
- doctoral degree (academic title Ph.D. or equivalent) in the field of real-estate development, real-estate engineering or related disciplines (architecture and urbanism, building construction, economics, spatial planning, strategic planning, regional development, housing and housing policy, urban engineering, urban studies, property valuation, social and economic geography, etc.).
- gaining the academic title of associate professor or the prerequisites for habilitation within the next 5 years
- research and publication activity in the field,
- fluent in English (knowledge of Czech or Slovak is an advantage)
- also welcome are:
 - knowledge of the academic setting and teaching experience
 - experience in private and public development and other professional qualities
 - knowledge of additional languages
- integrity.

Applications may be submitted in Czech, Slovak or English.

Process of the recruitment procedure:

The announcement of the recruitment procedure has been published on the official notice board of CTU and on the public part of the FA CTU website.

The fulfillment of the formal requirements of the application, as well as the qualifications and professional prerequisites of the applicants, are assessed by an expert committee appointed by the Dean, in accordance with the applicable internal regulations and based on the submitted documents.

At its discretion, the selection committee may invite all or selected applicants to an interview.

FA CTU reserves the right not to select any of the applicants. FA CTU is entitled to cancel the selection procedure at any time.
