- knowledge of an additional language and teaching experience at the university level, social engagement in the field of architecture, as well as in the promotion of the discipline, international experience, and preferably a completed doctoral degree, are welcome,

Applications may be submitted in Czech, Slovak or English.

**Process of the recruitment procedure:**

The fulfillment of the formal requirements of the application, as well as the qualifications and professional prerequisites of the applicants, are assessed by an expert committee appointed by the Dean, in accordance with the applicable internal regulations and based on the submitted documents.

At its discretion, the selection committee may invite all or selected applicants to an interview.

FA CTU reserves the right not to select any of the applicants. FA CTU is entitled to cancel the selection procedure at any time.
